❖ 設置



電源コードの上に重いものをのせたり、コードが本機の下敷きになったりしないようにしてください。また、コードをねじったり、引っ張ったり、加熱したり、熱器具に近づけたりしないでください。コードが傷んだらご加入のケーブルテレビ局に交換を依頼してください。そのまま使用すると破損して火災・感電の原因となります。



次のような使い方をしないでください。内部に熱がこもり、火災や故障の原因となるばかりか、周囲の器物に変形・変色・故障などの影響を与えることがあります。

- 押し入れや通気の悪いラックの中に設置する

❖ 設置



直射日光が当たる場所や熱器具の近くに置くと、火災の原因となることがあります。



電源プラグはコンセントに根元まで確実に差し込んでください。差し込みが不完全ですと、発熱したりほこりが付着して火災の原因となることがあります。また、電源プラグの刃に触れると感電することがあります。



本機を設置する場合には、壁から 10 cm 以上の間隔をおいてください。また、放熱をよくするために、他の機器との間は少し離して設置してください。

ラックなどに入れるときには、本機の天面から 1 cm 以上、背面から 10 cm 以上、側面から 1 cm 以上のすきまをあけてください。内部に熱がこもり、火災の原因となることがあります。



製品を電源から完全に遮断するためには、電源プラグ(遮断装置)をコンセントから抜く必要があります。製品はコンセントの近くで、電源プラグ(遮断装置)に容易に手が届くように設置してください。電源プラグを長時間差ししたままにすると、火災の原因となることがあります。

これらの機器と本機を同時に使用すると、電波の干渉により、通信がとぎれることがあります。

通信状況の改善方法としては以下の方法があります。

- ・電波を発生している相手機器の電源を切る。
- ・干渉している機器との距離を離して設置する。(本機を干渉している機器から離してください)

次の場所では本機を使用しないでください。双方向通信ができなくなる場合があります。

- ・本機以外の 2.4 GHz を利用する無線 LAN (IEEE802.11b/g/n)、また電子レンジなどの機器の磁場、静電気、電波障害が発生するところ。(環境により電波が届かない場合があります)
- ・ラジオからは離してお使いください。
- ・テレビにノイズが出た場合、本機がテレビ、ビデオ、BS チューナー、CS チューナーなどのアンテナ入力端子に影響を及ぼしている可能性があります。本機をアンテナ入力端子から遠ざけて設置してください。

使用範囲について

ご家庭内での使用に限りません（通信の環境により通信距離が短くなる場合があります）。

- 鉄筋コンクリートや金属の使われている壁や床を通して使用する場合。
- 大型の金属製家具の近くなど。
- 2.4 GHz を利用する無線 LAN (IEEE802.11b/g/n)、また電子レンジなどの機器の磁場、静電気、電波障害が発生するところ。
- 集合住宅（アパート・マンションなど）にお住まいで、お隣で使用している電子レンジ設置場所が本機に近い場合。なお、電子レンジは、使用してなければ電波干渉は起こりません。

電波の反射について

本機が通信する電波には、直接届く電波（直接波）と、壁や家具、建物などに反射してさまざまな方向から届く電波（反射波）があります。これにより、障害物と反射物とのさまざまな反射波が発生し、電波状態の良い位置と悪い位置が生じ、双方向通信がうまくできなくなることがあります。このようなときは、RF リモコンや本機の場所、または無線 LAN アクセスポイントを少し動かしてみてください。RF リモコンと本機の間、または無線 LAN アクセスポイントと本機の間を人間が横切ったり、近づいたりすることによっても反射波の影響で双方向通信がとぎれたりすることがあります。

動かない画像を長時間映さないでください。

本機に接続されたテレビやプラズマディスプレイに動かない画像を長時間映していると、画面に映像が焼き付いて影のように画面に残る恐れがあります。動かない画像を長時間映さないでください。

時刻設定について

本機では放送局から送られてくる時刻データに基づいて内部の時刻を設定しています。常に正しい時刻が設定されていますので、お客様に設定していただく必要はありません。

降雨対応放送

激しい降雨などによりケーブルセンターでの衛星放送の受信状況が悪くなり、番組が視聴しにくくなる場合があります。BS デジタル放送には、視聴に必要な最低限の情報を降雨に強い方式で送る降雨対応放送が用意されています。映像・音声かとぎれるようなときは、降雨対応放送を選ぶと、番組かとぎれることなく視聴できます。(降雨対応放送を行っていないチャンネルでは選べません。)

CAS カード (IC カード) について

- CAS カードは放送をお楽しみいただくための大切なカードです。CAS カードを挿入しないと有料放送を視聴できません。CAS カードは常時、挿入口に入れておいてください。
- 破損や紛失などのときは、ご加入のケーブルテレビ局にお問い合わせください。
- 本機では、CAS カードは「IC カード」と表示されることがあります。

CAS カード取り扱い上の注意

- CAS カードを折り曲げたり、傷をつけたり、変形させたりしないでください。
- CAS カードの上に重いものを置いたり踏みつけたりしないでください。
- CAS カードに水をかけたり、濡れた手で触ったりしないでください。
- CAS カードの IC (集積回路) 部には手を触れないでください。
- CAS カードの分解加工はしないでください。

録画について

内蔵 HDD、USB-HDD、LAN-HDD に録画するときのご注意

※ 本書では HDD（ハードディスク）を HDD と表記しています。

- ホームネットワーク機器で録画予約を使用する場合は、スタンバイ設定を通常モードにすることをお勧めします。
- ネットワークの通信が混雑していると、正しく録画できないことがあります。
- 接続している機器の性能や状態によって録画が停止したり、正しく録画できない場合があります。
- 録画時間が短いときは、ハードディスクに保存されないことがあります。また、コンテンツやチャプターの編集で指定した時間の間隔が短いときは、編集ができないことがあります。
- 視聴年齢制限番組やコピー制御番組などの切り換わりで、録画番組が分割されることがあります。
- 内蔵 HDD および USB-HDD の時間指定録画の場合は、番組の切り換わり毎に録画番組が分割されます。また、次の番組の録画準備のため、前の番組の最後が約 10 秒切れることがあります。
- 録画が禁止された番組は録画できません。
- 時間指定録画で録画中に録画禁止の番組が始まったときは、録画は中断されます。録画が可能な状態になると、再び録画が始まります。
- LAN-HDD の録画はダビング 10 には対応していませんので、1 回だけ録画可能な番組（コピーワンス）として録画されます。
- 内蔵 HDD または USB-HDD で連続した番組を予約録画したときは、次の予約の録画準備のため、前の番組の最後が約 10 秒切れることがあります。
- LAN-HDD で連続した番組を予約録画したときは、次の予約の録画準備のため、前の番組の最後が約 1 分 40 秒切れることがあります。
- 内蔵 HDD または USB-HDD と LAN-HDD で連続した番組を予約録画したときは、次の予約の録画準備のため、前の番組の最後が約 45 秒切れることがあります。
- HDD の残量が不足しているときは録画できません。
- HDD の電源がオフまたは USB/LAN ケーブルが抜けていると録画できません。
- 市販の DLNA 録画に対応した機器を本機に接続しても、正しく録画できない場合があります。
- 内蔵 HDD または USB-HDD の録画は、録画画質の設定にかかわらず、すべて一度「DR」で録画されます。その後、本機が録画などをしていないときに設定した録画画質に変換します。「DR」以外の録画画質で録画する場合は、「DR」で録画するときよりも一時的に大きな空き容量（残量時間）が必要になります。また、録画画質の変換中は USB-HDD の取り外しや無効操作はできませんので、ご注意ください。

内蔵 HDD に関するご注意

お客様ご自身で内蔵 HDD を交換することはできません。

設置や使用する時のご注意

本機の設置場所や取扱に十分な配慮が不足しますと、下記のような症状が発生します。

- 内蔵 HDD が故障する
- 内蔵 HDD に録画した内容が損なわれる
- 動作が中断する
- ノイズが記録される

上記のようなことを避けるため、次のことを守ってください。

- 下記のような場所には置かないでください。
 - 本機背面の冷却用ファンや通風孔をふさぐような狭いところ
 - 本機前面の扉が開けられないようなところ
 - 傾いたところ（水平に置いてください）
 - 振動の激しいところ（衝撃や振動を与えないでください）
 - 湿度の高いところ
 - 温度差の激しいところ
- 下記のような温度差の激しいところに設置すると、「結露」が起こることがあります。
 - 暖房をつけた直後
 - 湯気や湿気が立ちこめている部屋に置いてあるとき
 - 冷えた場所（部屋）から急に暖かい部屋に移動したとき

本機の内部に結露が起こったままお使いになると、HDD に傷がついて故障の原因になります。室内の温度変化は、毎時 10℃以下に保つことをお勧めします。結露がつくと信号が読み取れず、正常な動作をしないことがあります。結露をとるには電源を切り、結露がなくなるまで放置してください。そのままお使いになると、故障の原因になります。

- 電源が入っているときは下記にご注意ください。
 - 電源プラグをコンセントから抜かない
 - 本機を設置してある場所のプレーカーを落とさない
 - 本機を移動させない
- 本機を移動させるときは振動や衝撃を与えないでください。故障の原因になります。

内蔵 HDD の初期化について

お買い上げ時、内蔵 HDD は初期化された状態ですので初期化の必要はありません。

- こんなときに初期化をします。
 - 内蔵 HDD 内の録画番組を削除しても空き容量（残量時間）が増えないとき

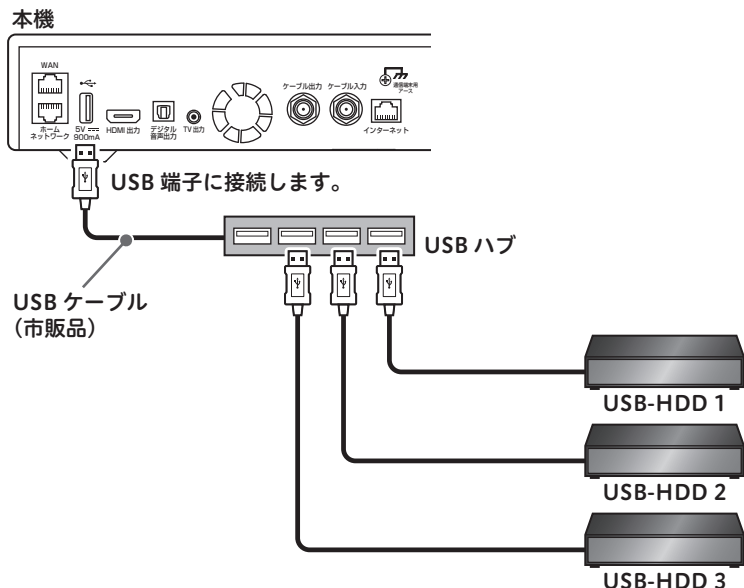

The licenses for most software are designed to take away your freedom to share and change it. 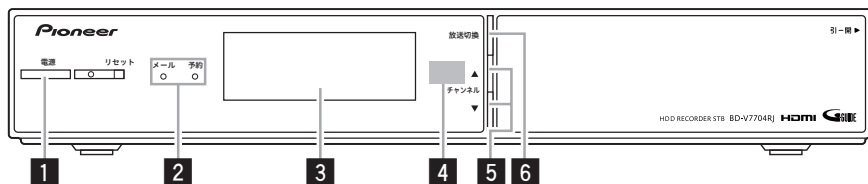
